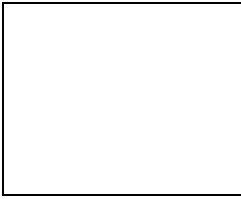

THE BUYER AGREES TO RETURN ALL EMPTY CYLINDERS TO THE SELLER IN GOOD CONTITION OR PAY TO THE SELLER THE REPLACEMENT VALUE OF ANY CYLINDER LOST, DAMAGED, OR DESTROYED. REFILLING OF ANY RENTAL CYLINDERS BY ANYONE OTHER THAN THE SELLER IS PROHIBITED. BUYER AGREES TO PAY \$5.00 PER MONTH PER EACH CYLINDER IN HIS POSSESSION ON THE LAST DAY OF EACH MONTH. THESE CYLINDERS ARE NOT TRANSFERABLE AND MUST BE RETURNED BY THE UNDERSIGNED.

THE UNDERSIGNED HEREBY UNCONDITIONALLY GUARANTEES TO CREDITOR FULL PAYMENT WHEN DUE, TOGETHER WITH LAWFUL INTEREST, ALL EXPENSES OF COLLECTION, INCLUDING COURT COSTS AND REASONABLE ATTORNEY FEES.
